Founded in 1972, the Granby Land Trust (GLT) works to preserve the natural heritage of the town through the conservation of its scenic and historic vistas, open space corridors, wildlife habitat, ecologically sensitive areas, and agricultural land.

PROPERTY ACQUISITION - This program includes the permanent protection of property acquired either by purchase or donation, or by conservation easement. The GLT conducts long term planning to determine appropriate priority corridors in the town, and concentrates its acquisition efforts in those areas. These efforts are conducted by volunteers and professionals and include the evaluation, negotiation and completion of new land acquisition projects.
